**14. STAFF REPORTS - 8:05 p.m.**

**14.a. 2016 Bond Measure Feasibility Survey - 8:05 p.m.**

Karen Maloney, Assistant Superintendent, Business & Operations, introduced

Charles Heath, TBWB, and Bryan Godbe, Godbe Research, who shared a PowerPoint presentation on the results of the 2016 Bond Measure Feasibility Survey which was conducted in December 2015 to gauge the public's perception of the District and to assess potential voter support for a bond measure to upgrade aging schools and to protect quality education in November. The questions included language such as:

- Provide science, technology, engineering, math and language labs and equipment to prepare students for college and careers, and
- Update classrooms, science labs and libraries with current technology to meet modern academic standards.

Key findings included:

- 59.8% thought NUSD is providing a quality education
- 59.5% agreed with the statement on whether NUSD needs additional funding
- 69.7% expressed initial support for the measure, and 74.3% expressed support after hearing the features and positives.

Given the survey findings, the 55 percent majority required for approval, TBWB and Godbe Research recommended that NUSD continue the process to prepare for a November 2016 bond measure election.

#### **14.b. Energy Conservation Program Update - 8:20 p.m.**

Scott Himes, Energy Specialist, reported on NUSD's Energy Conservation Program, which began in September 2012 with Cenergistic. This comprehensive energy program has reduced energy cost by 21.7% as of November 2015, resulting in a savings of \$808,237. The energy program success is the product of multiple factors; however, teamwork by the Maintenance Department, teaching staff, office staff, custodians, administrators, community and the Energy Specialist in making behavioral changes to conserve energy has been the most important factor in the success.

#### **14.c. Solar Update - 8:35 p.m.**

#### **14.d. NUSD Mid-year Goals Progress Report - 8:50 p.m.**

Jim Hogeboom, Superintendent, presented highlights from the NUSD Mid-Year Progress Report which was based on the twelve (12) goals and four (4) priority areas the Board of Trustee established in Fall 2015. The four priority areas are: Equity, Student Success, Staff Success and Community Engagement and Involvement. Some of the highlights included:

##### Equity:

- Continue Clark Consulting and hire a new ELD instructional coach to support training
- Continue GLAD training by instructional coaches
- Expand the Summer Newcomer Academy and Camp University

- The Spanish Journey to the University Event in November was attended by 184 students/parents
- Increase the graduation rate from 92 percent to 94 percent

Student Success:

- Convened a District Advisory Committee (DAC) which identified "6Cs" Big C's: Collaboration, Communication, Critical Thinking, and Little C's: Conscientious Learner, Cultural Competence, Character as skills that all Novato students need to learn and demonstrate as part a Graduate Portfolio
- Increase the percentage of students meeting or exceeding the standards on the Smarter Balanced (SBAC) assessment in math from 48 percent to 53 percent, and increase the percentage of students meeting or exceeding the standards on the Smarter Balanced (SBAC) assessment in English Language Arts/Literacy from 56 percent to 61 percent.
- Create benchmarks in math and English Language Arts based on CCSS standards.
- Implement Elementary Standards Based Report Card in March and gather teacher feedback.
- Expand Pre-K
- Implement career pathways and partner with the College of Marin to increase NUSD student concurrent enrollment.

Staff Success:

- Survey teachers on the quality of support received form instructional coaches and staff development.
- Strengthen relationship with local universities to recruit teachers

Community Involvement and Engagement:

- Track the number of community meetings and attendees. As of 1/20/16, the district has held approximately 29 meetings with approximately 1,673 attendees.
- Board Highlights in English/Spanish after every meeting.
- Superintendent Hogeboom video series
- Community Liaisons to be hired at all elementary and middle schools which is almost complete.

Karen Maloney, Assistant Superintendent, Business & Operations, introduced David Williard, Sage Renewables Consultant, who shared a PowerPoint presentation on the "Solar Photovoltaic Project Update," which updated the

Board of Trustees on the selection of Solar City as the solar installation and maintenance firm for the District. The district received only one proposal in response to the Request for Proposal (RFP) and Solar City submitted a competitive proposal that was reviewed by Sage Renewables and District staff. It was determined that the proposal, as submitted by Solar City, was competitive based on their company performance, pricing, component selection, designs, proposed schedule and ability to deliver the project.

With Board approval, the District can enter into negotiations with Solar City to establish the contract scope and cost of installation, and the financing method. The final contract will be presented to the Board for approval at the regularly scheduled Board meeting on March 1, 2016.
