GUIDELINES FOR NUSD HIGH SCHOOL ATHLETIC PUBLIC ADDRESS SYSTEMS

Outside User Group Use

Music & Announcing

1. No amplified music or announcements will be played through the P.A. system prior to 10:00 a.m.
2. No amplified music will be played through the P.A. system between plays. Music is okay during timeouts, change of possession, quarter & half breaks, team introductions and cheer performances.
3. No profane music will be played. Monitored by Person-in-Charge and/or Facilities Coordinator.
4. Any end of game music shall be played at the predetermined reasonable volume level.
5. Announcing the game play by play is permissible as long as the volume is within an appropriate range for the number of spectators.
6. No microphone checks shall commence prior to 9:55 a.m.
7. Prior to the beginning of each contest the designated Person-in-Charge and/or the Facilities Coordinator must establish the maximum reasonable volume setting on the amplifier for all announcements and music.
8. The public address system is for games only and is not to be used during practices.

General

9. At NHS, the visitor bleachers shall not be used for non-school events prior to 9:00a.m.
10. No artificial noise makers allowed by spectators i.e. air horns, whistles, bells, etc. Game officials use of such devices are allowed to properly control and time the contest.
11. The District Facilities Coordinator will ensure that these guidelines are enforced and communicated to the person(s) who control the public address system. Complaints should be directed to the Facilities Coordinator at 415-493-4205.
12. Any exceptions to these guidelines will require District administrative approval.

NUSD Use

Music & Announcing

1. No amplified music will be played through the P.A. system prior to the National Anthem or team introductions for the first game of the day.
2. No amplified music will be played through the P.A. system between plays. Music is okay during timeouts, change of possession, quarter and half breaks, team introductions and cheer performances.
3. No profane music will be played. The Athletic Director or Administrator on duty shall monitor.
4. Any end of game music shall be played at the predetermined reasonable volume level.
5. Announcing the game play by play is permissible as long as the volume is within the appropriate range as establish by the administrator for the number of spectators. No microphone checks shall commence prior to 9:15 am.
6. Prior to the beginning of each contest the athletic director (AD) and/or the administrator on duty must establish the maximum reasonable volume setting on the amplifier for all announcements, music, and commentaries.
7. The public address system is for games only and is not to be used during practices.

General

8. The athletic director, the administrator in-charge, or the District Facilities Coordinator will ensure that these guidelines are enforced and communicated to the person(s) who control the public address system.
9. The Athletic Director at each high school will ensure that these guidelines are enforced and communicated to the person(s) who control the public address system. Complaints should be directed to the Athletic Director at the offending high school.
10. No artificial noise makers allowed by spectators i.e. air horns, whistles, bells, etc. Game official's use of such devices are allowed to properly control and time the contest.
11. Any exceptions to these guidelines will require administrative approval.
