The purpose of this grant is to support overall coordination of Healthy Novato Initiative grants and a School-Based Prevention Coordinator. The terms of this Healthy Novato Community Initiative (HNCI) grant are as follows:

1. Assure that program services are integrated and allow for productive communication by working with the HNCI Leadership Group, NUSD's School Based Prevention Facilitator and HNCI stipend teachers at each school site.
2. Ensure alignment between agency program staff and HNCI Leadership Group principles/mission. This will include supporting bidirectional flow of information among respective program staff and the Leadership Group.
3. Work with HNCI consultant Christina Borbely to organize workplan content in order to inform input for mid-year and end of year reports.
4. Use "SMART" format for outcome statements (specific, measurable, achievable, realistic, timebound); if needed consult with an evaluation expert to firm up plans to be accountable for demonstrating achievement of objectives & proposed outcomes.
5. Restrict grant funds to the goals of HNCI. End of year carryover must be accounted for and/or applied to the next year's expenses.
6. Submit reports (template attached) by January 31, 2017 and July 31, 2017.


